

WIREBARLEY 10TH ANNIVERSARY PROMOTIONS SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

VOID WHERE PROHIBITED BY LAW.

1. Sponsor

WireBarley, Corp. (the "Sponsor" or "WireBarley").

2. Promotion Period

The promotions begin on April 13, 2026 at 12:00:00 AM Eastern Daylight Time ("EDT") and end on May 10, 2026 at 11:59:59 PM EDT (the "Promotion Period"). Sponsor's computer is the official time-keeping device.

3. Overview

These Official Rules govern two separate promotions (collectively, the "Promotions"):

1. **Promotion 1: Fly Home to Your Loved Ones** (a sweepstakes / random drawing)
2. **Promotion 2: A Special Welcome for Your First Send** (a coupon offer)

Eligible participants may participate in Promotion 1 and Promotion 2 concurrently, subject to these Official Rules.

4. PROMOTION 1 — Fly Home to Your Loved Ones (Sweepstakes)

4.1 Eligibility

Promotion 1 is open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older as of April 13, 2026 and who possess a web-enabled mobile device.

Employees, officers, and directors of Sponsor and its respective parent companies, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies, and each of their immediate family members (spouse, parents, children, and siblings and their spouses) and household members (whether related or not) are not eligible to enter or win.

Void where prohibited.

4.2 How to Enter

There are two (2) methods of entry. All eligible entries, regardless of method of entry, will be treated equally.

Method 1 — Online Entry: During the Promotion Period, visit the WireBarley promotion page and click the **[Enter for Airfare]** button to complete your entry.

Method 2 — Mail-In Entry (Alternate Method of Entry/AMOE): To enter without using the Online Entry method, print your full name, mailing address, email address, and phone number on a plain piece of paper, and clearly write "WireBarley 10th Anniversary Sweepstakes Entry" at the top. Mail your entry in a business-size (#10) envelope with sufficient first-class postage affixed to:

Mail-In Entry Requirements:

- Entries must be postmarked by May 10, 2026 and received by May 17, 2026
- Hand-print all required information legibly.
- Each entry must be mailed separately in a separate envelope.
- Entries with insufficient postage or illegible information will be disqualified.
- Mechanically reproduced entries are not permitted.

Entry Limitations: Limit one (1) entry per person during the Sweepstakes Period, regardless of method of entry. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, registrations, logins, or any other methods will void that Entrant's entries and that Entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification.

Equal Treatment: All eligible entries, whether submitted online or by mail, will be treated equally and will have an equal chance of winning.

In the event of a dispute as to the identity of an Entrant, the authorized account holder of the email address or mobile account used to enter will be deemed to be the Entrant. Proof of submission will not be deemed to be proof of receipt by Sponsor.

By entering, Entrants agree to receive promotional emails and app push notifications from Sponsor. Entrants may opt-out of receiving future promotional communications as described in any such communication.

4.3 Winner Selection

On or about May 20, 2026, Sponsor or its designated representative will conduct a random drawing from among all eligible entries received during the Promotion Period to select **one (1) potential winner**.

Odds of winning depend on the number of eligible entries received.

4.4 Winner Notification; Forfeiture

Potential winner will be notified individually via App Push and/or Email using the contact information provided at the time of entry on or about May 20, 2026.

Response Requirement: Potential winner must respond within five (5) days of the notification attempt. If the potential winner does not respond within the specified time period, or if the notification is returned as undeliverable, or if the potential winner is found to be ineligible, does not comply with these Official Rules, or declines the prize for any reason prior to award, the potential winner may be disqualified and the prize may be forfeited. Sponsor may select an alternate potential winner from among the remaining eligible entries.

Winner's List: For the name of the winner, send a self-addressed stamped envelope to: 626 Wilshire Blvd, #420, Los Angeles CA, 90017. Requests must be received within ninety (90) days after the Winner Announcement date.

Affidavit and Release: Except where prohibited by law, potential Grand Prize, First Prize, and Second Prize winners may be required to complete, sign, and return an Affidavit of Eligibility, a Liability Release, and (where legal) a Publicity Release within the time period specified in the notification. Failure to comply may result in disqualification and selection of an alternate winner.

4.5 Prize

Grand Prize (1 winner): One (1) winner will receive a **\$1,000 airfare credit** (the "Prize").

Total ARV: \$1,000.00.

- Specific instructions regarding prize delivery/redemption will be provided individually to the winner.
- Sponsor is not responsible for missed notifications due to incorrect or outdated information.
- Winner is solely responsible for obtaining any travel documents, visas, and complying with U.S. entry requirements (if applicable). Failure to do so may result in forfeiture without substitution.

4.6 Taxes

Winner is responsible for all applicable federal, state, and local taxes, if any.

5. PROMOTION 2 — A Special Welcome for Your First Send (\$10 Welcome Coupon)

5.1 Conditional Promotional Offer

Eligible customers will receive a **\$10 welcome coupon**.

5.2 Eligibility

Promotion 2 is available to customers who **successfully complete their first transfer of \$1,000 or more** during the Promotion Period (April 13, 2026 00:00 EDT through May 10, 2026 23:59 EDT). Only successfully completed transactions are eligible.

5.3 Coupon Distribution; Notification

Coupons will be issued on or about May 20, 2026. Customers will be notified individually once the coupon/credit has been issued.

5.4 Additional Terms

Coupon is subject to Sponsor's coupon policy and any additional terms provided at the time of issuance.

6. Marketing Communications

Entrants may receive marketing communications from Sponsor. To receive

notifications, please go to App > Notification Settings > Push Notifications ON. Entrants may opt out of receiving marketing emails at any time by following the unsubscribe instructions provided in any marketing email or by contacting Sponsor directly.

7. Privacy

Personal Information Collection and Use: By entering this Sweepstakes, Entrants consent to the collection and use of their personal information by Sponsor for the purposes of administering and operating this Sweepstakes, including but not limited to: (a) processing entries; (b) conducting the random drawing; (c) notifying and verifying potential winners; (d) fulfilling prizes; and (e) complying with applicable laws and regulations.
