1. NO PURCHASE NECESSARY

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. This Sweepstakes is intended for play in the United States only and shall be construed and evaluated according to United States law. Entry into this Sweepstakes does not constitute entry into any other promotion, contest, or sweepstakes.

2. ELIGIBILITY

This Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older as of January 26, 2026, and who possess a web-enabled mobile device.

Additional Eligibility Requirements:

Employees, officers, and directors of WireBarley, LAFC, and their respective parent companies, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies, and each of their immediate family members (spouse, parents, children, and siblings and their spouses) and household members (whether related or not) are not eligible to enter or win.

3. SWEEPSTAKES PERIOD

4. HOW TO ENTER

Method 1 - Online Entry (WireBarley Customers): During the Sweepstakes Period, visit the WireBarley LAFC Sweepstakes promotion page and click the [Enter Now] button to complete

your entry. This method is available only to current members of WireBarley's U.S. remittance service who have fully completed identity verification.

Method 2 - Mail-In Entry (Alternate Method of Entry/AMOE): To enter without being a WireBarley customer, print your full name, mailing address, email address, and phone number on a plain piece of paper, and clearly write "WireBarley LAFC Sweepstakes Entry" at the top. Mail-In Entry Requirements:

Entries must be postmarked by February 7, 2026 and received by February 9, 2026.

Hand-print all required information legibly.

Each entry must be mailed separately in a separate envelope.

Entries with insufficient postage or illegible information will be disqualified.

Mechanically reproduced entries are not permitted.

Entry Limitations: Limit one (1) entry per person during the Sweepstakes Period, regardless of method of entry. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, registrations, logins, or any other methods will void that Entrant's entries and that Entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification.

5. WINNER SELECTION

Odds of Winning: Odds of winning depend on the number of eligible entries received during the Sweepstakes Period.

Participation Prize: All eligible participants will receive a WireBarley \$3 Coupon, regardless of whether they win a prize in the random drawing.

The decisions of Sponsor are final and binding in all respects. Winners will be notified as set forth in Section 7 below.

6. PRIZE DETAILS

GRAND PRIZE (2 winners): Each Grand Prize winner will receive two (2) tickets to the LAFC Season Opening Match scheduled for February 21, 2026 (Saturday), based on local Los Angeles time (Pacific Time). Approximate Retail Value ("ARV"): ranges between \$178 - \$880 per prize package (based on ticket values ranging from \$89 - \$440 per ticket). Total ARV of all Grand Prizes: \$356 - \$1,760.

Prize Details:

Match date and time are subject to change depending on the club or organizer's circumstances. Tickets will be delivered via email. Detailed ticket delivery instructions will be provided individually to winners.

Sponsor is not responsible if the match is delayed, postponed, or cancelled for any reason. No compensation or substitution will be provided.

SECOND PRIZE (5 winners): Each Second Prize winner will receive one (1) LAFC Official Supporter Scarf. ARV: \$39.99 per prize. Total ARV of all Second Prizes: \$199.95.

Prize Fulfillment:

Detailed shipping information for First Prize and Second Prize items will be provided individually to winners.

Prizes will be shipped to the address provided by winner. Sponsor is not responsible for lost, late, or misdirected mail.

PARTICIPATION PRIZE (All eligible entrants): Each eligible entrant who completes an entry will receive one (1) WireBarley \$3 Coupon. ARV: \$3.00 per coupon.

Coupon Details:

Coupon Eligibility: Coupons are available only to WireBarley U.S. remittance service members who enter via Method 1 (Online Entry). Entrants who enter via Method 2 (Mail-In Entry/AMOE) are not eligible to receive the participation coupon, as the coupon is only valid for use by active WireBarley account holders.

Coupons may be used to deduct remittance fees. If a transaction has no applicable fees, the receiving remittance amount will remain the same while the coupon amount will be deducted from the actual payment (sending) amount.

Coupons will be distributed in bulk on February 9, 2026, after the Sweepstakes ends.
